Announcements

Motion: Moved by Milton Ragsdale that the Kona (Oahu) select two (2) District Representatives Pro Tempore until the formal election to represent the moku at the general Coalition meetings. Motion passes by unanimous consent.

Nominations were open for Kona (Oahu) District Representatives Pro Tempore.

Nomination made by Milton Ragsdale for Sterling Ing; Seconded; Sterling Ing accepts the nomination.

Nomination by Kau'i Torres for Milton Ragsdale; Seconded; Milton Ragsdale accepts.

Nomination by Sterling Ing for Dathan Hill; Seconded; Dathan Hill accepts.

Motion: Moved by Milton Ragsdale to have 2 representatives and one alternate; Seconded. Motion passes unanimous consent.

Vote Taken

Results: Dathan Hill and Milton Ragsdale will be the elected Kona (Oahu) District Representatives Pro Tempore.

Alternate: Kona (Oahu) District Representatives Pro Tempore Sterling Ing.

Motion: Moved by Umi and seconded to have the next meeting on April 26 for the Kona Moku meeting, location to be announced.

Appoints all committees chairs with approval of EC and NHC

3 Vice-Chair

The three vice-chairs shall exercise all duties and powers in the absence of a chair.

Assign duties as determined by chair.

Oversight of committees assigned by chair

Secretary

Record minutes of all meetings

Maintains all records

Disseminates materials (correspondence)

Provide general support for EC

Responsible for response to all communications upon advance from the Chair Records votes and all decisions On no account shall permit original documents to be withdrawn from unless advised by EC

Treasurer:

Perform all duties with in his/her jurisdiction as a member of the NHC as deemed applicable Fiscal oversight of all NHC activities If treasurer is unable, a vice-chair shall temporarily fulfill as determined by the EC.
